#### ARTICLES OF ORGANIZATION

#### ATM-KMB PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I

#### NAME AND ADDRESS

The name of the limited liability company shall be ATM-KMB Properties, LLC (the "Company"). The mailing address of the principal office in Florida shall be P.O. #### ARTICLE II

#### PURPOSES AND POWERS

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida.
