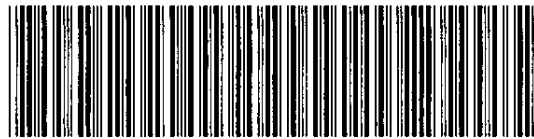

Article I of the Articles of Organization of this Company is amended in its entirety to read as follows:


ARTICLE I
