ARTICLE NINE

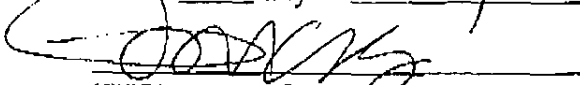

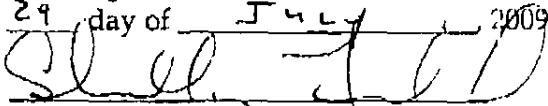

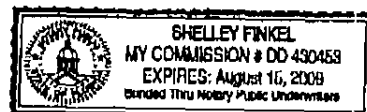
