ARTICLES OF ORGANIZATION

OF

CONCH-N-CHEDDAR, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **CONCH-N-CHEDDAR**, **LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall 2017 S.W. 67th Drive, Okeechobee, Florida 34974, and the mailing address shall be the same.

No additional member(s) shall be admitted to the Company except within the unanimous written consent of all the member(s) of the Company and upon such terms and conditions as shall be determined by all the member(s).
