ARTICLES OF ORGANIZATION OF

SIMPLEX FINANCIAL LLC

ARTICLE I

NAME

The name of this Limited Liability Company shall be SIMPLEX FINANCIAL LLC. (the "Company").

ARTICLE II

The Company shall exist perpetually unless sooner dissolved in a manner provided by law, or as provided in the regulations adopted by the members (the "Regulations").

ARTICLE VII NEW MEMBERS

No additional members shall be admitted to the Company, and no member may transfer his or her interest in the Company, except, in either case as set forth in the Regulations, and if there are no Regulations then in effect, by unanimous consent of all of the members. Contributions of new members shall be determined as of their time of admission to the Company.

The Company shall be terminated and dissolved upon:

- (A) the vote of all members holding an interest in the Company;
- (B) the expiration of the term of the Company; or
- the death, retirement, or resignation of a member, if the remaining members do not vote unanimously to continue the business of the Company.


