The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be **WellMeaning Properties, LLC, Florida limited liability company** (the "Company").

#### **ARTICLE V -- CAPITAL CONTRIBUTIONS**

The Regulations and the Operating Agreement, if any, shall determine the manner in which such the Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the company not inconsistent with the law or these Articles of Organization. The Company shall indemnify each Member, Manager and Organizer of the Company in accordance with the Operating Agreement


