**ARTICLES OF ORGANIZATION
OF
ST. AUGUSTINE INVESTMENT GROUP, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as the same may from time to time be amended (the "Act").

ARTICLE I - NAME

The name of this limited liability company (the "Company") is St. Augustine Investment Group, LLC.

ARTICLE II - ADDRESS

ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT


ARTICLE IV - MANAGEMENT OF THE COMPANY


