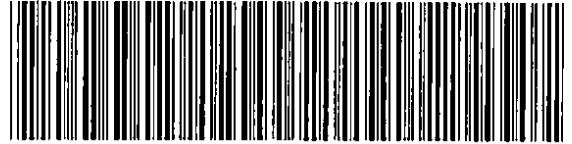

The original articles of organization (the "Articles of Organization") of MyQ America, LLC, a Florida limited liability company (the "Company"), were filed with the Secretary of State of the State of Florida on August 3, 2009, and assigned Florida Document Number L09000074414.

In accordance with Chapters 605 of the Florida Statutes, the Articles of Organization of the Company are hereby amended and restated in its entirety to read as follows:

**ARTICLE I
COMPANY NAME**

The name of the limited liability company is MyQ America, LLC (the "Company").

The initial managers shall hold their positions until they are removed, resign, or are otherwise no longer able to fulfill their duties as managers.

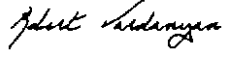
ARTICLE VI OFFICERS

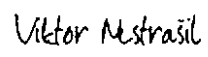
