We were forced to dissolve the company. We never opened. ABDI LLC continued to string us along forcing us to spend more and more money. At no time did Mr. Rodrigues give us

the keys to the property, he only allowed his partner, Antonio Sylva to let us in to conduct interviews for workers and to view the inside and to meet with the alarm providers and extorminators etc.



