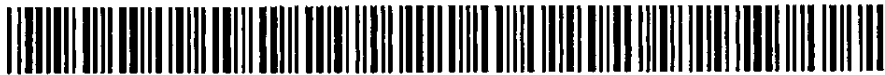

MAILING AND PRINCIPAL ADDRESS


