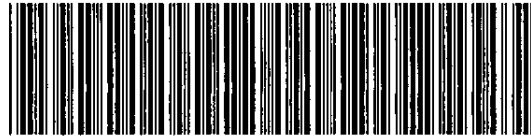

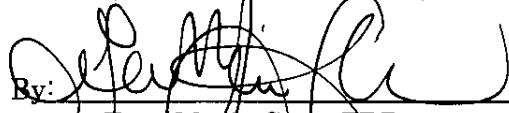

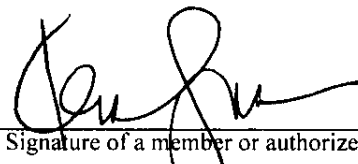
**FIRST:** The Articles of Organization were filed on August 5, 2009 and assigned document number L09000075229.
