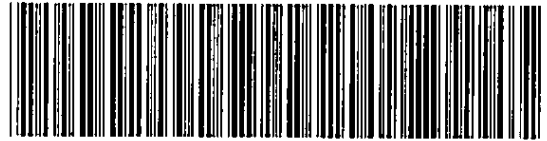

**FIRST AMENDMENT  
TO THE  
ARTICLES OF ORGANIZATION  
OF  
JCZM INVESTMENTS, LLC**  
(a Florida limited liability company)

**JCZM INVESTMENTS, LLC**, a Florida limited liability company (the "LLC") filed Articles of Organization on August 6, 2009. The LLC was assigned a Florida document number L09000075625. Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby adopts the following Amendment to the Articles of Organization:
