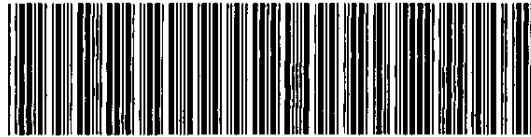



NAME




