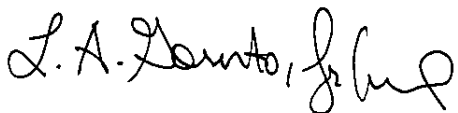

NAME

The name of this limited liability company is Canal Street Holdings 100, LLC.

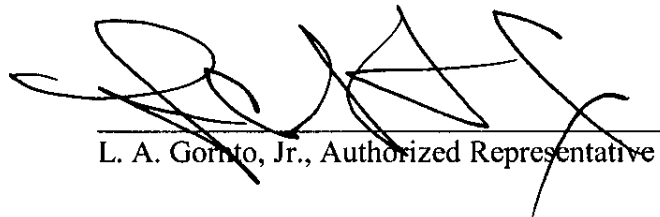

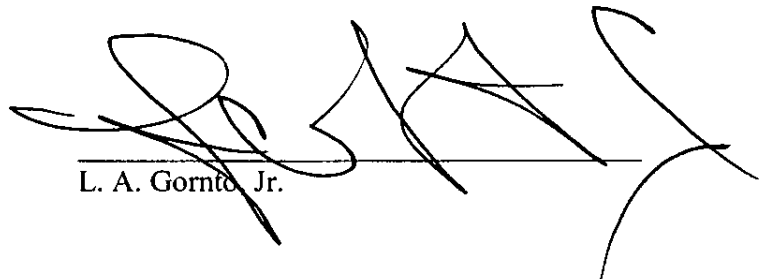
