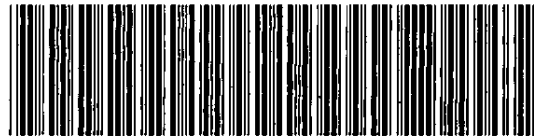



**ARTICLE I**

**NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this limited liability company shall be GREEN HIBISCUS TRANSPORTATION COMPANY, LLC, and the mailing address and street address of its principal office shall be 15121 Gulistan Avenue, Port Charlotte, FL 33953, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

**ARTICLE II**

**PURPOSES AND POWERS**


