# **ARTICLES OF ORGANIZATION**

### <u>OF</u>

### NORTH FLORIDA CELLULAR AT GOVERNOR'S SQUARE, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

# 1. <u>NAME</u>.

The name of the Limited Liability Company is North Florida Cellular at Governor's Square, LLC (hereinafter referred to as the "Company").

## 1. **PERIOD OF DURATION**.

The period of duration of the Company shall be from the date of filing.

Articles of Organization until the first to occur of the following:

- (i) The date that is seventy-five (75) years from the date of filing of the Articles of Organization with the Department of State, State of Florida;
- (ii) Dissolution of the Company pursuant to the provisions of the Florida.

  Limited Liability Act; or
- (iii) By the mutual written agreement of a majority in capital interest of the Members.

#### 2. **PURPOSE**.

Contributions to the capital of the Company shall be made by the Methbers from time to time, in the manner prescribed by a written Operating Agreement to be made and entered into by the Members, and which may be amended from time to time in accordance will its terms.

#### 6. **MEMBERS**.

The Company shall have at least one (1) Member, and may admit additional members upon the prior unanimous written agreement of the then existing Members, or as otherwise provided in the Operating Agreement. The initial member of the company is:
