2. Article I of the Articles of Organization of the Company is hereby deleted in its entirety and replaced with the following, in order to change the name of the Company:

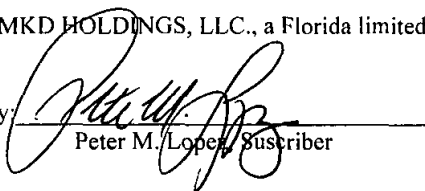
**ARTICLE I: NAME**

IN WITNESS WHEREOF, the Company has caused these Articles of Amendment to be executed as of the 17<sup>th</sup> day of September, 2010.

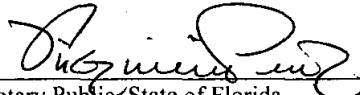
