**ARTICLES OF ORGANIZATION

ARTICLE I

ARTICLE IX

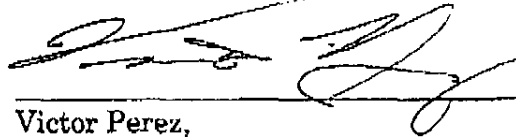
OPERATING AGREEMENT

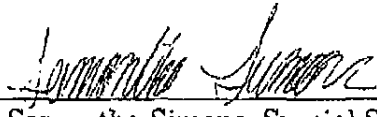
