The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the Act), for purposes of forming a limited liability company under the laws of the State of Florida, do set forth the following:

# 1. <u>Name.</u>

The name of the limited liability company is PASSIVE GREEN, LLC (hereinafter referred to as the "Company").

## 2. Period of Duration.

Unless earlier terminated under the Act or the Operative Agreement, the period of duration of the Company shall be perpetual.

#### 3. Purpose.

Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
