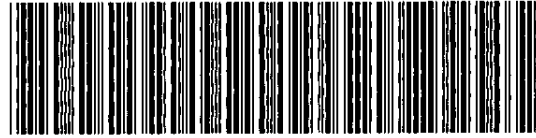

ARTICLE V- BUSINESS PURPOSE

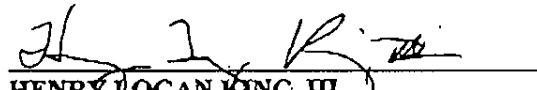
The primary business purpose of this Company is real estate investment and agriculture, in addition to any other purposes permitted under Florida law.

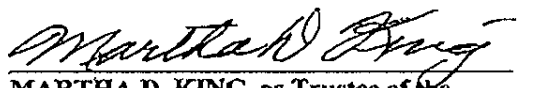
ARTICLE VI - EFFECTIVE DATE
