**ARTICLES OF ORGANIZATION OF

WILLIAMS, D.D.S., M.S., PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 608, *Florida Statutes*.

ARTICLE I

The name of the professional limited liability company is:
