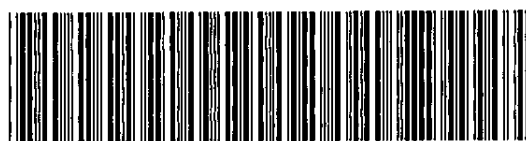

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Limited Liability Company (hereinafter referred to as the "Company") shall be:

PK Solar, LLC

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

The address of the principal place of business of the Company shall be 2550 Goodlette Frank Road, Unit #1, Naples, Florida 34103, and the mailing address of the Company shall be 2550 Goodlette Frank Road, Unit #1, Naples, Florida 34103.

ARTICLE III. TERM OF EXISTENCE

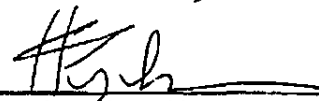
