ARTICLES OF ORGANIZATION OF FRANK E. LOZANO, JR., DMD, P.L.

The undersigned, being duly licensed to practice dentistry in the state of Florida, and being authorized to execute and file these Articles of Organization to form a professional limited liability company under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the state of Florida, hereby certifies that:

ARTICLE I - Name:

The name of the limited liability company (hereinafter referred to as the "Company") is:

ARTICLE VIII - Members' Right to Continue Business:

Except as set forth in the regulations, the company shall be dissolved on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, unless the business of the company is continued by majority vote of all remaining members.

ARTICLE IX - Limitation on Agency Authority of Members

Pursuant to Section 608.4235 of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.
