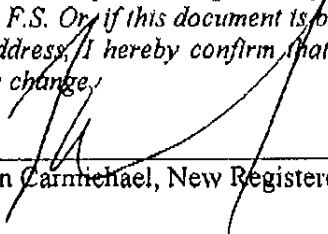
**SECOND:** The following amendment to the Articles of Organization was adopted by unanimous consent of the Managing Members of the limited liability company:

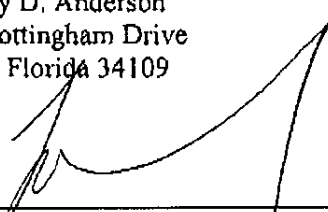
