Articles of Organization of SOUTHERN ARTS STUDIOS, LLC

The undersigned, pursuant to Fla. Stat. § 608.407, as amended, does hereby adopt the following Articles of Organization for its limited liability company (the "Company").

ARTICLE I - Name

ARTICLE II - Registered Office
