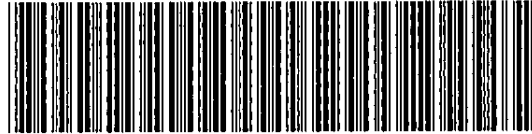

The name of the Limited Liability Company is VENTURES SEVEN WEST COAST, LLC (the "Company").




