AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY FOR TRU PALM, LLC

Pursuant to the provisions of section 608.411, Florida Statutes, this Florida limited liability compadopts the following Amended and Restated Articles of Organization.

ARTICLE I NAME

The name of the Limited Liability Company shall be Tru Palm, LLC, hereinafter "Company". mailing address of the Company shall be 1925 Blackstone Circle, Naples, FL 34109. The principal plac business shall be 100 Benoist Farms Rd., West Palm Beach, FL 33411.

ARTICLE II DURATION

The Company shall commence its existence on the date these Articles of Organization are filed with Florida Department of State. The Company shall have a perpetual existence, unless the Company is ea dissolved as provided in these Articles of Organization.

ARTICLE III PURPOSE AND POWERS
