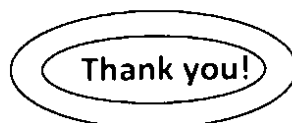


THESE ARTICLES OF MERGER, dated November 29, 2022, are filed pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act (the "FRLLC") and relate to the merger (the "Merger") of AEGIS FIRE AND INTEGRATED SERVICES, LLC, a Florida limited liability company, with and into REPUBLIC FIRE PROTECTION, INC., a Delaware corporation.

1. The merging parties are REPUBLIC FIRE PROTECTION, INC., a Delaware corporation ("Republic"), and AEGIS FIRE AND INTEGRATED SERVICES, LLC, a Florida limited liability company ("Aegis").
2. Republic shall be the surviving entity of the Merger.
3. The merger was approved by each domestic merging entity that is a limited liability company in accordance with Sections 605.1021-605.1026 of the FRLLC; by each other merging entity in accordance with the laws of its jurisdiction; and by each member of such limited liability company who as a result of the merger will have interest holder liability under Section 605.1023(1)(b) of the FRLLC.
4. Republic is a foreign entity that does not have a certificate of authority to transact business in the state of Florida. The mailing address to which the department may send any process served pursuant to s. 605.0117 and Chapter 48, Florida Statutes is 1025 Telegraph Street, Reno, NV 89502.
5. Republic agrees to pay any members with appraisal rights the amount, to which members are entitled under Sections 605.1006 and 605.1061-605.1072 of the FRLLC.
6. The Merger shall be effective upon filing these Articles of Merger with the State of Florida.
