**ARTICLE VIII – MEMBERS RIGHTS TO CONTINUE BUSINESS**



**ARTICLES OF ORGANIZATION  
OF  
CANADIAN IMMIGRANT INVESTOR PROGRAM, LLC**

The undersigned organizer, pursuant to Section 608.407 Florida Statutes, as amended, does hereby adopt the following Articles of Organization for such limited liability company (the "Company").

**ARTICLE I - NAME**
