The undersigned, HARRY B. STACKHOUSE, a natural person competent to contract and an authorized representative of the member of GABO, LLC, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I
