OF

**ARTICLE I
NAME**

The name of the Professional Limited Liability Company (the "Company") is LERRO & CHANDROSS, PLLC.

**ARTICLE II
ADDRESS**

**ARTICLE III
DURATION**

The period of duration for the Company shall begin on the date of filing these Articles of Organization with the Florida Secretary of State and shall have a perpetual existence and duration, until terminated in accordance with applicable law.

**ARTICLE IV
PURPOSES AND POWERS**

In addition to the powers authorized by the State of Florida for professional limited liability companies, the general nature of the business to be transacted is the practice of accountancy.




