### ARTICLES OF ORGANIZATION OF SNOWSHOE STEELER, LLC

The undersigned, for the purpose of forming a limited liability company and file the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be SNOWSHOE STEELER, LLC, ("company").

#### **ARTICLE II - ADDRESS**

The mailing address of the principal office of the company is P. O. Box 217, Tangerine, FL 32777 and the street address of the principal office of the company is 4900 Lake Park Ct., Mt. Dora, FL 32757.

#### ARTICLE III - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

#### ARTICLE IV – REGISTERED AGENT AND OFFICE

A member may transfer his or her interest in the company as set forth in the Operating Agreement of the company.

#### ARTICLE VI – MEMBERSHIP UNITS

Each of the units shall entitle the holder thereof to one (1) vote at any meeting of the Members. The business may be continued only on the unanimous written consent of the remaining members.

#### ARTICLE VIII - MANAGEMENT

The company shall be managed by the members in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the company. This Operating Agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
