# ARTICLES OF ORGANIZATION OF SAKE CAFÉ TALLAHASSEE, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

### 1. NAME.

The name of the Limited Liability Company is **SAKE CAFÉ TALLAHASSEE**, **LLC** (hereinafter referred to as the "Company").

### 2. **PERIOD OF DURATION**.

### 7. ADDITIONAL MEMBERS.

The Company shall have two (2) members, and may admit additional members upon the prior unanimous written agreement of the then existing members, or as otherwise provided in the Operating Agreement.

### 8. <u>CONTINUITY OF BUSINESS.</u>

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members of the Company.

### 9. MANAGEMENT.
