#### ARTICLE I NAME

#### ARTICLE VI RIGHT TO CONTINUE BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall not cease and the Company shall not be dissolved except by the unanimous consent of the remaining members or as otherwise provided in the Operating Agreement of the Company.

#### ARTICLE VII RESTRICTIONS ON MEMBERSHIP

New members shall be admitted to the Company in accordance with the Operating Agreement of the Company. Contributions required of a new member shall be determined in accordance with the Operating Agreement of the Company. Additional restrictions and conditions on membership may be set forth in the Operating Agreement or other agreement adopted by the members.

The members of the Company may adopt an Operating Agreement pertaining to the regulation, management, and other affairs of the Company.

## ARTICLE IX REGISTERED OFFICE AND REGISTERED AGENT

The Company may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Section 608.416, Florida Statutes.
