The undersigned person, seeking to form a limited liability company under the Florida s, Chapter 608, hereby executes the following Articles of Organization Statutes, Chapter 608, hereby executes the following Articles of Organization.

- NAME. The name of the limited liability company shall be: Kaleem Medical Properties, L.L.C. ("Company").
- H ADDRESS. The initial mailing address and street address of the principal office of the Company shall be 700 Zeagler Drive, Suite 2, Palatka, Florida 32177.
