The name of the limited liability company is: Green Bull, LLC.

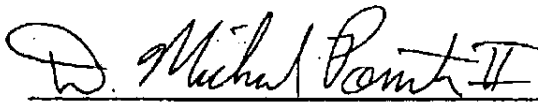
ARTICLE II. ADDRESS
