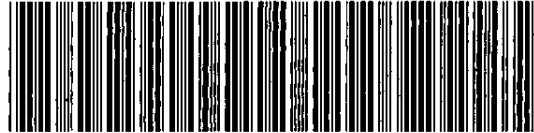

ARTICLES OF ORGANIZATION

OF

ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized member, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I: NAME

The name of the limited liability company is **MOORE COLOR, LLC**, (the "Company").

ARTICLE II: ADDRESS

The Company's mailing address and street address of the principal office of the Company is 13351 Whisper Bay Dr., Clermont, Florida 34711.

ARTICLE III: DURATION

The management of this Company is reserved to the members and is, therefore a member-managed company. The initial member-manager is **BRUCE MOORE**, 13351 Whisper Bay Dr., Clermont, FL 34711.

ARTICLE IX: REGULATIONS

The power to adopt, alter, amend, or repeal the Regulations of the Company will be vested in the Members of the Company.

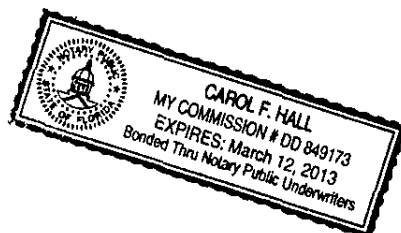
