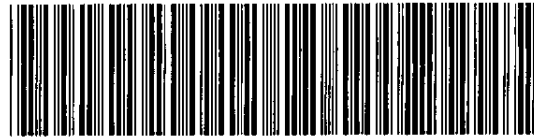

ARTICLE V- BUSINESS PURPOSE


