The undersigned authorized representative does hereby certify that the persons so identified herein have associated themselves together for the purpose of forming a limited liability company (the "Company") under the laws of the State of Florida.

ARTICLE I NAME

The name of the Company shall be: KJF Properties, LLC

ARTICLE II ADDRESS AND PLACE OF BUSINESS

ARTICLE IX REGISTERED OFFICE AND REGISTERED AGENT
