ARTICLE I

The amendment was duly approved by the joint written consent to action of the members of the Company.

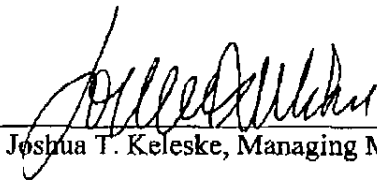
