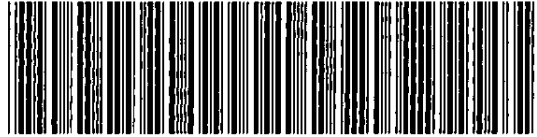

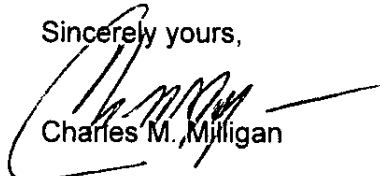

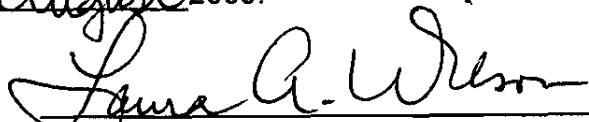
1. The name of the limited liability company is **LASER SOLUTIONS OF THE FLORIDA KEYS, L.L.C.**

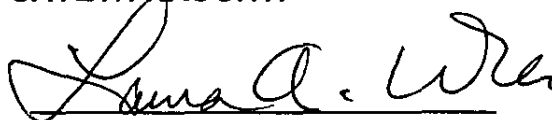
