The mailing address and street address of the principal office of the Company is 933 Magdalena Road, Palm Beach Gardens, Florida 33410.


**ARTICLE III - REGISTERED AGENT**

**ARTICLE IV - MANAGEMENT BY MEMBERS**


The Company is to be managed by one or more of its Members, and is, therefore, a member managed limited liability company.
