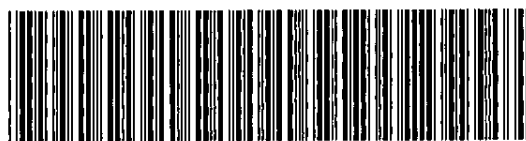



## **ARTICLES OF ORGANIZATION**

### **OF 5310 TOWER ROAD, L.L.C.**


