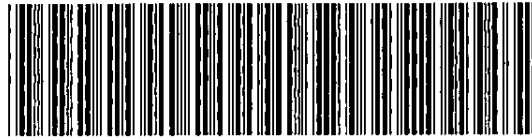

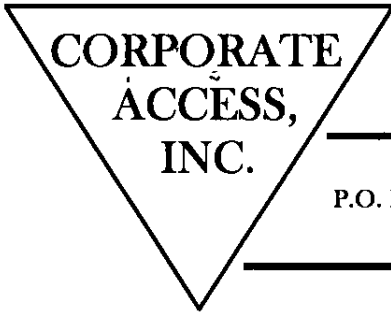


ARTICLE IV — MANAGEMENT:


