Currently, the Trust has two (2) co-trustees, Northern Trust, NA and Marion Preston.

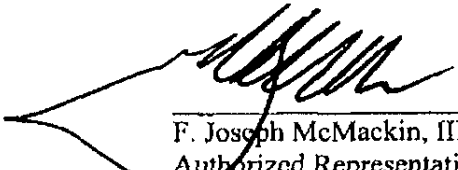
Article 5. Commencement of Existence

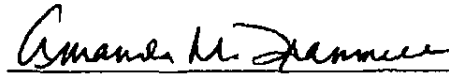
