ARTICLES OF ORGANIZATION

Impressive Yacht Management, LLC

I, the undersigned, hereby associate myself for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation of a limited liability company for profit, with the powers, rights, privileges and immunities hereinafter, and I do make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Organization, and to that end I do by these Articles set forth:

ARTICLE I

NAME

The name of the limited liability company shall be **Impressive Yacht Management, LLC**.

ARTICLE II

DURATION

The duration of the limited liability company shall be perpetual unless sooner dissolved according to law.

ARTICLE III

PURPOSE

The general nature of the business, objects and purposes proposed to be carried on and transacted, are to do any and all lawful business for which limited liability company may be formed under the laws of the State of Florida including but not limited to the following:

- (a) Operation of a yacht management and servicing company;
- (b) To borrow money and contract debts when necessary for the transaction of the business or for the exercise of its rights, privileges, or franchises, or for any other lawful purpose of its formation; to issue bonds, promissory notes, bills of exchange, debentures and other obligations and evidences of indebtedness payable at a specified time or times, or payable on the happening of a specified event or events, whether secured by mortgage, pledge or otherwise, or unsecured, for money borrowed or in payment for property purchased or acquired, or for any other lawful object;
- (c) The purposes specified herein shall be construed both as powers and purposes and shall in no wise be limited to or restricted by reference to, or inference from, the terms of any other clause in this or any other Article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers shall not be construed to limit or restrict in any manner the meaning of the general terms of or the general powers of the limited

liability company under the laws of the State of Florida; nor shall the expression of one thing be deemed to exclude another, although it be of like nature, not expressed;

(d) To do all and everything necessary and proper for the accomplishment of the objects enumerated in these Articles of Organization, and in general to carry on any lawful business necessary or incidental to the attainment similar in nature to the objects set forth herein.

ARTICLE IV
