ARTICLES OF ORGANIZATION

OF

BLUE SKIES CAR SERVICE, LLC

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set fourth the following:

1. Name

The name of the limited liability company is **Blue Skies Car Service**, **LLC** (hereinafter referred to as the "Company")

2. Purpose

The purpose for which the Company is organized is to operate a car service, and any and all other business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

3. Address of Place of Business

The mailing address for the company is 1133 SE Palm Beach Road, Port Saint Lucie, Florida 34952-5314, and the street address of the place of business for the company is 1133 SE Palm Beach Road, Port Saint Lucie, Florida, 34952. These addresses may be changed from time to time as provided in the Operating Agreement.

4. Registered Agent

The initial registered agent in Florida for the Company is Robert L. Jennings, Esq., and the initial registered office is located at 306 SE Detroit Avenue, Stuart, Florida 34994.

5. Capital Contributions

Contributions to the capital of the Company shall be made by members, in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

6. Members

The Company shall have two members initially and may add additional members or delete members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement.

7. Continuity of business

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the



business of the Company may be continued and the Company will not be dissolved without the prior written consent of all the remaining members of the Company.

8. Management

The overall management and control of the business and affairs of the Company shall be vested in its members, as provided in these Articles of Organization and section 608.407 of the Act. Any and all action by the Company shall require the vote of members holding a majority interest in the Company.

9. Indemnification.

Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
