ARTICLES OF ORGANIZATION OF



RMSK SOLUTION PROVIDER LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **RMSK SOLUTION PROVIDER LLC**, (hereinafter "Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 1921 Lago Vista Boulevard, Palm Harbor, Florida 34685, and the mailing address shall be the same.
