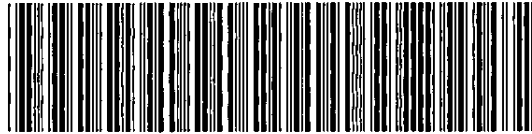

**ARTICLES OF ORGANIZATION
FOR
RETINA NETWORK ONE, LLC**

A Florida Limited Liability Company

The undersigned, RETINA NETWORK ONE, LLC (the "Company"), desiring to form a limited liability company under the Florida Limited Liability Company Act, codified as Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization of such Company.

The Company is to be managed by its Managers. The persons who will serve as Managers until the first annual meeting of Members or until their successors are elected and qualified are:


