ARTICLES OF ORGANIZATION FOR BKK PARTNERS, LLC

ARTICLE I – NAME

The name of the Limited Liability Company is BKK PARTNERS, LLC.

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is:

225 South Adams Street, Suite 250 Tallahassee, FL 32301

ARTICLE III – DURATION

The period of duration for the Limited Liability Company shall be perpetual.

ARTICLE IV – MEMBER UNITS

The Limited Liability Company is authorized to issue 10,000 Units of membership interest, which Units shall evidence the interest of the members of the Limited Liability Company, which Units shall be designated "Members Units." The interest of the members of the Limited Liability Company shall be evidenced by the Certificate of Limited Liability Company Units issued by the Limited Liability Company and setting forth the number of Member Units issued and outstanding in the name of such member.

ARTICLE V – MANAGEMENT
